

The newly published standard BSEN13120:2009+A1:2014, relating in particular to internal blinds with accessible inners cords (Roman Blinds) deals with protection from strangulation in two specific areas. As from **Monday 24th March 2014** our H700 Cassette Blind System will include all labels and components to ensure customers can supply compliant blinds.

## Operating chains

- The bottom loop of the chain must be at least 150cm above the floor.
- The chain loop must be secured using the retainer supplied.
- The appropriate labels must remain attached to both chain loop and retainer.

# Internal blind cords (lifting cords)

When the distance between two consecutive attachment/retention points is greater than 200mm (8" approx) the following will apply:-

- All lifting cords must be secured using the break away devices supplied, as shown above
- All warning labels will be in place as required.
- Full instructions will be included with each kit.
- Jones branded headrails identify your supply chain.
- Jones break away device is suitable for use with roman blind tapes, cording eyelet and blind rings.

This diagram further illustrates the key points made above.

- Please note that all H700 Cassette Blind System (standard lengths) where the installation height is not known will be supplied with 100cm chain loops.
- Made to measure metal chains can be ordered.
- Made to measure systems will be supplied with chain loops made to the correct lengths, calculated from the installation heights indicated on the H700 made to measure form. www.jones-interors.com/download.
